MINUTES

Chair Mollenhauer called the meeting to order at 4:30 p.m.

President Sundberg introduced Mr. Tobey Harrison, Associate Vice President of Emergency & Public Safety. Mr. Harrison started in this new position at Kirkwood on February 3, 2020.

Chair Mollenhauer declared the meeting open for public hearing on:

- 1) Issuance of 2020A Refunding Bonds and the Series 2020B Certificates
- 2) Iowa Hall Addition and Renovations, Library/Benton Hall Renovations and Central Campus Greenspace Project

There being no questions or comments, Trustees Ovel and Rennekamp moved and seconded the hearing be closed. Motion carried: 8-0.

Trustees Stamp and Thys moved and seconded approval of the minutes from the regular board meeting held on January 9, 2020, and directed them to be made a part of the permanent record. Motion carried: 8-0.

Trustees Swanson and Williams moved and seconded approval of the February 13, 2020 agenda. Motion carried: 8-0.

INFORMATIONAL ITEMS

Kirkwood Report:

Justin Hoehn, Associate Director of Marketing, provided the Eagle Update and Kirkwood report, which included:

- Kirkwood will begin a two-year long construction phase to transform Iowa Hall into a state-of-the-art student center. The new student center is scheduled to open in the fall of 2022. During construction some areas will be off limits. Wayfinding videos have been created to show students how to get from one area to another on campus. The videos are available on the website.
- On February 4, 2020 former board of trustee chair, Wayne T. Newton passed away. Wayne dedicated 30 years to Kirkwood and to community colleges throughout the United States. His dedication to Kirkwood and community colleges everywhere will be greatly missed.
- Student of the month: Mayuri Shelar is an international student from Mumbai, India. She came to Kirkwood six months ago on a one-year Community College Initiative (CCI) scholarship funded by the US Department of State. She is studying Business Administration Management and her long-term goal is to start a non-profit in her community that provides workshops for young adults to learn and build their professional skills.
- Kirkwood has earned a Tree Campus USA designation for 2019. There are 385 campuses across the United States with this distinction and only three are community colleges.
- The Kirkwood Ag program recently acquired a new Sprayer Simulator. Students going into the agronomy industry can now gain hands on experience operating a sprayer applicator

- without actually operating a real machine. Kirkwood is the first college in Iowa to own this simulator and one of only 16 currently in the U.S.
- The Communique won 10 awards at the annual Iowa College Media Association convention in Des Moines on Feb. 6. The Communique was the only participating community college newspaper to win awards.
- Former student, Anna Soenksen, graduated from Kirkwood in 2012 with a Graphic Communications Technology degree, designed the Super Bowl 54 championship t-shirt for the Kansas City Chiefs players and fans.

FlexFORWARD Program:

Colette Atkins, Dean of Business and Information Technology, Dave Hunt, Associate Dean of Distance Learning and John Henik, Associate Vice President of Academic Affairs provided an introduction to Kirkwood's Competency Based Education branded as FlexFORWARD for Kirkwood. FlexFORWARD provides the non-traditional student with an alternate schedule in addition to an academic coach to assist students in completing a degree or obtaining a certificate. The program currently serves students in either Business Administration Management or Project Management Certificate.

Enrollment Report:

Jon Buse, Vice President of Student Services, provided the enrollment update for the Spring semester 2020:

- Enrollment for spring is currently 12,435.
- 3.8% decline overall.
- Declines are noted with non-degree seeking students, non-cohort nursing students and some
 of the CTE applied sciences.
- Concurrent enrollment remains steady.
- Persistence enrollment is up 1%.

Financial Report:

Treasurer Choate provided the current financial update with a focus on the year to date actuals compared to the FY20 Budget:

- FY20 revenue and expenditure analysis through December 2019 presented.
- Review the current property tax levy and the proposed FY21 levy rate. The increase from FY20 of 1.21677 to FY21 of 1.25712 will primarily cover the planned safety and security measures that need to be implemented.
- Anticipated property tax cost to homeowner in FY21 on a \$100k home will be an additional \$0.18.
- Review of the debt action plan during FY20 will strengthen the balance sheet going forward to FY25
- At the end of January 2020 there is an unrestricted cash reserve of 116 days of operation.

- MLK Day and Employee Recognition was held January 20. The new format focusing on honoring MLK and diversity has been well received. Thank you to the Trustees who were able to attend.
- Hosting area business roundtable discussions to get to know area employers and find out about their workforce needs. These have been going well. The next one will be in Iowa City later this month.
- Met with HLT and we are working on a partnership with them where they can access the SIM Lab for training videos and in return provide our nursing students with free access to the HLT Application for two years.
- Asked to join the City of Cedar Rapids Business Advisory Council.

Secretary's Report:

• Each trustee received a professional Kirkwood name badge to wear for various events.

Report of Board Members:

Trustee Jensen attended the Student Legislative Seminar in Des Moines January 22nd. Kirkwood students were unable to attend due to the winter weather. The legislators seem to respond well to the student's visit. He shared a reminder that the 2020 Community College Day on the Hill is March 3 from 7:00 a.m. to 12:30 p.m.

Trustees Rennekamp and Ovel attended the ACCT National Legislative Seminar in Washington DC. IACCT membership was well represented. Trustee Ovel reports there has been some good traction with short-term Pell grants. Both Trustees felt they had good visits with representatives from the Department of Labor and the Department of Education. As a member of the ACCT Communications Committee, Trustee Rennekamp reported there will be a toolkit available with ideas on how to promote community colleges during the month of April. Both report the visit was well organized and productive.
